- b) to present to the thirty-third session of the General Assembly, through the ECOSOC, specific recommendations on possible humanitarian, legal and financial aid to those arbitrarily arrested or imprisoned, to those forced to leave the country and to their relatives.
- c) to submit to the thirty-third session of the General Assembly, through the ECOSOC, a report of action taken in compliance with operative paragraph 5c.
- 7. Requests the President of the thirty-second session of the General Assembly and the Secretary-General to assist in any way they may consider appropriate in the re-establishment of basic human rights and fundamental freedoms in Chile.
